EVENT	DESCRIPTION	STEPS OF ACTIONS TO BE TAKEN			
FIRE	Observation of smoke or flames, audible fire alarm	If you discover smoke or flames, pull nearest fire pull station and evacuate.	Evacuate Building. Use the nearest exit to a safe distance (300 ft.) and assist others as needed.	Call 9-911 and do not re-enter the building listen to any directions from safety.	After alarms silence, a Safety Officer will announce ALL CLEAR & return to building.
TORNADO WARNING	Severe Tornado Watch or Warning	Weather conditions are continuously monitored and announcements will be made when to evacuate.	Tornado Watch. Be aware of conditions and prepared to take shelter in a designated shelter area.	Tornado Warning. Immediately seek shelter in a designated shelter area.	Remain in the designated Tornado shelter area until ALL CLEAR is announced.
MEDICAL EMERGENCY	Accident or illness resulting in a medical emergency on campus	Provide immediate aid as needed. Contact 9-911 & Safety Officer.	Report Emergency. All injuries and exposure incidents occurring on campus, whether an emergency or not, must be reported to a supervisor, Human Resources & Safety Officer.		
POWER FAILURE	Loss of electricity and lights to any part of the campus	Remain calm, assist others as needed and use emergency flashlights.	Assess extent of outage i.e. (isolated to one room, one floor, entire building) Contact Safety Officer.	An overhead announcement may provide guidance to remain in place or evacuate Building.	
HAZARDOUS SPILL	Accidental release of substance that may present a hazard to persons/environment	Large spill – Evacuate. Contact 9-911 & Safety Officer.	Small spill – Contain. Contact Safety Officer.	Have anyone exposed remain in a safe area until responders or safety arrives.	Review MSDS for exposure protocols, and coordinate mitigation resources.
BOMB THREAT SUSPICIOUS PACKAGE	Discovery of note/message or phone threat of a bomb on campus grounds	Phone Threat. Gather as much information as possible from the caller.	Discovery of suspicious note, mail or package. Do not move, touch or handle object, isolate the object if possible and safe to do so. Contact Safety Officer.		
CAMPUS LOCKDOWN	Incident requiring students/faculty/staff to shelter in place & minimize threat	Immediately Evacuate if safe or go to nearest office/classroom and secure yourself inside.	Close, Lock or Barricade Doors. Remain calm, quiet and away from windows.	Call 9-911 & Safety Officer. Remain in the safe area until notified by safety or emergency responders that the situation has been resolved.	
STUDENT CODE OF CONDUCT	Student inappropriate or abusive behaviors violates university Code of Conduct policy	Imminent Safety Concern. Contact Safety Officer. To address safety interests or support removal of student.	Threat Evaluation Process The Behavioral Intervention Team could be scheduled to access the concerns for immediate intervention.	Judicial Affairs Officer. Contact the Code of Conduct Officer at 651-793-1535 to review interests.
