#### Some examples:

**Plagiarism**: copying text from a publication or the internet without citing your source, paraphrasing someone else's thoughts or words without giving them credit, passing someone else's spoken words off as your own.

Cheating: copying from others during exams, using illegal notes during exams, taking an exam for another student, submitting work for credit in more than one course without prior consent, preparing answers or notes in blue books before exams, allowing others to do assignments or papers for you, unauthorized collaboration on academic work.

**Deception**: falsifying research or data in an assignment, forging or altering college documents or records, furnishing false information to a university official.

**Disrespect of others**: using non-inclusive or inappropriate language, intolerance of other people's differences and opinions, leaving your cell phone on during class.



### **Potential Consequences**

Classroom behavior is left to the discretion of the professor. Some consequences may include, but are not limited to: disciplinary action by the University, review of academic standing, administrative drop from a course, course failure, additional or make-up work, negative reference checks resulting in difficulty finding employment.



### **Avoid trouble**

- \* Cite sources and give credit for borrowed words, works or ideas.
- \* Avoid academic dishonesty.
- Treat others as you wish to be treated.
- \* Talk to professors or advisors if you are feeling lost or behind.
- \* Ask **whenever** you are unsure.

# **Contract for Student Conduct**
