Kristine Hansen convened the meeting at 5:30 p.m. Hansen introduced Joseph Ellis '19 (Honorary), incoming Foundation Board chair. Ellis thanked the Alumni Board members for their service and looks forward to the collaboration to advocate for Metro State. Ellis is invited to attend future Alumni Board meetings.

President Arthur was unable to join the meeting due to traveling to Mississippi to seek federal funding that might be available for the Cyber Security Center.

Approval of committee notes

Board members reviewed the committee notes prior to the board meeting. Motion to approve the committee notes moved by Shahbaz Shah, seconded by Scott Pilgram, and the motion passed by a unanimous vote.

Office updates by Kristine Hansen

- Vice President Rita Dibble has been on an extended leave and will officially leave the university at the end of September.
- Hansen shared the words of gratitude from 2021 Alumnus of the Year, Steve Campos '17, and 2021-2022 Emergent Alumnus of the Year, James Houston '16, in response to the committee's selection of the awards.
- The office is planning a volunteer recognition and celebration on October 6. Campos and Houston will also be recognized for their awards at that time. Watch for the invitation.

Presentation of officer slate by Ryan Ringwelski:

The Executive Committee recommended the following members for the FY23 officers:

• Nancy Uden as President

Background—The Board originally planned to ask Samuel Farrand, then vice president, to take over the presidency at the end of Nancy Uden's two-year presidential term. Due to Farrand's mid-term departure, the Executive Committee requested Uden to continue the presidency for another year to maintain continuity of the Board's business, to mentor the vice president for the subsequent presidency term, and to ensure a smooth transition.

Uden graciously agreed to assume the additional year of presidency to assist the Executive Committee in defining the President's role and how they can delegate some responsibilities and accountability to the rest of the members.

The Executive Committee hopes the officer slate be an open election process in the future, where everyone can nominate each other or self-nominate for officer positions. This can be achieved once we meet more often in-person and get to know each other more.

The Executive Committee will work on creating an organizational chart to indicate who is involved in what committees, what their roles are, and how the committees report back to the Board.

- Ringwelski was impressed with the breadth of experience and diversity in the pool of candidates. The newly-approved board members will be notified of their official membership and will be invited to the August 5 social and the board retreat in September/October.

Membership Committee approached this year's recruitment process differently. The committee:

- 1) created the application—questions based on the membership qualifications.
- 2) cast the application for board membership through LinkedIn and also encouraged current nonboard committee members to consider membership.
- 3) offered multiple information sessions for those who were interested in the membership.
- 4) conducted interviews of those who were interested after the information session.
- 5) managed the candidates within the *Hubspot* platform for communication among committee members.

Lyna Nyamwaya, who was on a leave of absence in FY22, will return to the Board in September.

Retreat and committee selections:

• Board retreat is being planned for late September or early October. Hansen will send a Survey Monkey link to vote on the dates and times. Hansen strongly encourages members to attend inperson, but a remote option will be offered for those who cannot physically attend.

Value proposition discussion by Fidelis Odozi:

Communications Committee developed the Board's value proposition by identifying the needs and barriers of alumni and offering solutions to their needs. It was reviewed and articulated by the Executive Committee.

This promise to alumni and students serves as an indication, aspiration, and reminder for the board members to discover the purpose and fulfillment of their advocacy and service. It aligns with the Board's focus on creating pathways for near and recent graduates.

Other business and updates:

- Fundraising Committee has been in discussion on how to motivate alumni to give to Metro State. It has explored an idea of supporting recent graduates with professional development and financial support, such as testing fees, membership fees, certification fees, etc. With the value proposition in place, the committee can focus on how to translate its values to targeted segments of alumni.

- Over 100 alumni signed up for the mentoring software, *PeopleGrove*. The office is hosting a mentor orientation on August 9. Board members are invited to attend.

- The Foundation and Fundraising Committee are seeking volunteers to write and mail "thank you" postcards to FY22 donors. Each volunteer will be tasked with sending 25 postcards (or more if driven). The office will provide postcards, a list of donors, a sample script, and stamps. Let Hansen know if willing and able to complete the task within the next two weeks.
- Shah mentioned that the *Hubspot*-branded free website is available for the Board if interested.
