Metropolitan State University (Metro) is the only Minnesota State System University in the Twin Cities. To fulfill their mission to serve students from across the metro area of Minneapolis and St. Paul they have developed numerous partnerships and rented facilities throughout the Twin Cities. The Statement of Accreditation Status on the HLC website identifies that in addition to the Main Campus, Metro has a total of 15 approved "additional locations".

Metro groups their locations into five distinct groups. The first is the main campus located in St. Paul. The second which they identify as their Midway campus location is rented from a management company. In order to achieve their mission, they have developed partnerships with each of the ten Minnesota state two-year colleges in the Twin Cities. Two of these they consider as rented campus locations. Metro's Management Education Center and School of Urban Education are located at Minneapolis College and their Public Safety and Police Science Center is on the Hennepin Technical College Campus. They also rent classroom space at other educational institutions such as Saint Paul College in order to deliver courses at locations convenient for students. The final location type is within correctional facilities. Metro is offering the BA and BAS in Individualized Studies at three correctional facilities which are located from 12 to 54 miles from the main campus.

Both through information shared and comments made during the multi-location visit it is apparent that Metro conscientiously balances its focus on service to the metro area with the results of analysis of enrollment trends. Course enrollment trends since 2019 indicated that the majority of course enrollments were in online or hybrid courses. As a result, they have consolidated space both on the St. Paul campus and at their Midway site. Current plans include the permanent reduction of leased space at Midway, with the vacating of that site in the summer of 2026. The University is not projecting additional locations in the next three years.

The planning and maintenance of additional locations is core to the mission and legislative charge of Metro State to serve the entire Twin Cities area. Through its continual evaluation of existing programs, enrollment trends, and strategic identification of unmet needs and potential opportunities the University plans for growth, reductions, and relocation of programs as appropriate. Each location is connected to an academic dean who oversees the academic programs at that location, and they have budgetary oversight for the academic programs in their unit. It is the enrollment and the course schedule at each of the locations that determines the resource allocation. The University has demonstrated that it is willing to take whatever actions are appropriate in regard to responding to enrollment and new strategic

take whatever actions are appropriate in regard to responding to enrollment and new strategic opportunities. For example, they closed the Dental Clinic at Maplewood and are working toward a reduction in space and eventual closing of their Midway site. In contrast, they have expanded their

Metropolitan State University completed a comprehensive facility planning process between 2022 and 2024 which engage stakeholders to review space and program needs. The President's Advisory Group on Space oversees a regular process for space requests and prioritizes requests based on impact and available budget. Two off-campus locations were visited as a part of the multi-location visit.

Minneapolis Community College, where Metro houses its Management Education Center, and the School of Urban Education was one of the locations visited. The classrooms for the School of Urban Education are located in main building for the two-year college and thus students have easy access to food/snack service and study areas. The Management Education Center was located across the street in a very recently renovated building. Faculty, staff and student representatives were involved in multiple planning sessions with architects to design these renovations. Employees from both Metro and Minneapolis College as well as students were very proud of the facility and of the future possibilities this building will provide. In addition to classrooms including up-to-date technology the building had numerous small group collaborative work/study rooms throughout. Being located within another educational institution also ensured that issues such as handicapped accessibility or security were addressed. As with any major building renovation a few "glitches" occurred once actual usage began, however it was noted these were take care of quickly. Regular meetings between Metro and Minneapolis staff at multiple levels ensure a successful partnership at this location. A parking ramp is located immediately across the street and there is a walkway directly from it into the Minneapolis College main building. Students from Metro can park there as a part of their tuition. Public transportation also serves this location.

The second facility which was visited was the Minnesota Correctional Facility in Stillwater. The educational wing where Metro holds classes is in a secure area and includes classrooms on two floors. There was a main classroom which is where a class was observed, a library across the hallway and an art room on an upper level. The area was well light, and a comfortable temperature. There was sufficient spacing for the tables and chairs used by the students attending class to allow for interaction not only with the instructor but also with other students. Because of the type of location some features such as internet access in the classroom are not allowed

The staffing and academic support is sufficient for the course offerings and course enrollment at each of the locations visited. Academic deans are directly responsible for the assignment of faculty and staff to a specific location in support of the overall instructional effectiveness and current enrollment trends. These locations are handled in no way differently than the main campus. There are several policies which are

associated with instructional assignments at Metro State, and these are applied uniformly to all individuals and all sites. These include Policy 5140: Resident Faculty Assignment of Workload and Application for Overload Assignments, Policy 2200/ Procedure 220 Minimum Faculty Qualifications.

In the case of the Minneapolis College location where two entire departments are housed, the Institutional Effectiveness and Technology Division has identified a dedicated IT professional. This was especially helpful with the recent major remodel and will continue to be so given the focus on increasing programing at that location.

In the case of the Transformation and Re-entry through Education and Community (TREC) program at Stillwater dedicated staff manage the University's relationship with the Minnesota Department of Corrections. There are two individuals, the Director, College in Prisons Program (TREC) and the Metro State Prison Education Program Coordinator who assure that instructor and student needs are met.

Metro State serves a very diverse and dispersed population of non-traditional students, many of whom are employed. Although there are students who regularly use both in-person and online support, it was noted that 2,180 respondents to their fall 2024 Student Impact Survey indicated that they largely prefer online (synchronous) and email-based student support. For students on the Minneapolis campus, they have access to Library material and support in person on the St Paul campus but also electronically. Zoom based synchronous tutorials are available and the writing center also offers asynchronous writing tutorials. Any student may go to the main campus but can also use technology for a variety of student support areas. In conversation with students, it became apparent that for many they do not identify with a single Metro location and have their needs met at the location and time of most convenience to them.

Given the restrictions of the TREC students at the Stillwater Prison a more structured plan is in place for the providing of student support. Regular academic advising occurs with onsite faculty advisors. Through the cooperative efforts of Metro and MDOC staff, students are advised and registered for courses. Weekly learning labs are scheduled twice a week at the facility to provide writing and other academic support. Although there is a library at the prison, its collection is more casual reading, and thus a Metro faculty librarian provides library resources and research support. For TREC students with disabilities there is an accessibility plan in place to provide accommodation. Students' access to instructional technology is limited, although they do have access to DOC issued laptops, which are regulated and monitored by DOC and a LMS which has specifically been designed for prison sites.

Metro State has a number of processes in place that are embedded within their institutional culture and organization's operational structure that encourages continuous quality improvement not only at the two sites visited but throughout the organization. A sampling of these processes includes Program Annual

Reflections, Annual Division Strategic Work Planning, Assessment of Student Learning and Academic Program Review.

What was specifically noted at the Minneapolis College location was the level of communications on an ongoing regularly scheduled basis that permeated all levels of the two organizations. Monthly meetings of two groups were mentioned, the first that included administrative levels that would address planning and policy level decisions and a second group that reviewed and discussed more operational issues. It was obvious that this frequent conversation allowed for both efforts that addressed continuous quality improvement of current programming but also allowed for strategic future focused planning.

In relation to Metro's offering at the Stillwater Prison, it was obvious that Metro's faculty and staff in concert with the DOC educational program staff work as a Team with a focus on enhancing the inmate's success within the restrictions of a prison environment. For instances when the facility implemented restrictions related to the use of paper Metro in concert with the prison's educational staff responded in developing alternatives within the restrictions to maintain a quality instructional process.

The major source of marketing for Metro State's publicly offered programs it its web presence. While there are numerous content liaisons from various departments, actual changes to the website is limited to the marketing and IT staff. Any change must be requested through a service portal which allows for the review of all proposed content for accuracy.

For the correctional facility at Stillwater the identification of potential participants is closely coordinated with DOC. The direct link between the Metro campus and individuals who are Metro employees located at the prison ensures that current program and course information is available. The Metro correction-based employees then work closely with the correctional facility employees to assure that accurate information is provided to the inmates through their one-on-one advising.
